1. When booking for a scheduled course, a registration form is to be completed and submitted, along with a copy of your ID and emailed to **info@avitir.co.za**.
2. No course will be confirmed until either a deposit or full payment (as required per course) and all other documents are received i.e. Registration form, copy of your ID etc.
3. All bookings are subject to availability at time of receipt of payment.
4. The balance of the payment must be paid before the course examination.
5. Cancellations within 14 working days prior to course commencement will result in forfeiting the deposit as a cancellation fee, however given more than 14 working days notice you will be eligible for a refund, less an administration fee of ZAR200.
6. Bookings made within 14 working days require full payment upon registering.
7. Postponements will be allowed provided that the request is made at least 14 working days prior to the original date and will be subject to availability for the new date.
8. AVITIR reserves the right to change the course dates. AVITIR will notify students accordingly, with sufficient notification prior to the dates being changed.
9. No-shows will be subject to 100% cancellation fee.
